I further agree to save and hold harmless, indemnify, and defend AITP from any claim by me or by my family, arising out of my participation in this festival in War Memorial Park, Pass Christian, MS.

In addition, I agree to abide by the guidelines of **ART IN THE PASS**. and I understand that there will be no responsibility incurred by the Festival or its sponsors for any loss, damaged or stolen merchandise.
